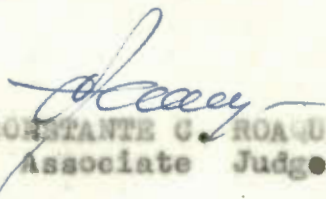
RESOLUTION

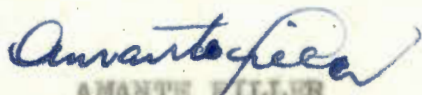
