This certifies that **EXCELSIUS ENGINEERING SERVICES** (TIN: _____), an entity engaged by the National Housing Authority (NHA), is exempt from project-related income taxes and creditable withholding tax and value added tax (VAT), pursuant to Section 26 (d)(1) and (3) of Republic Act No. 7279, as amended by RA No. 10884 (Balanced Housing Development Program Amendments) dated July 17, 2016, on its income received directly in connection with the construction of Socialized housing units under the NHA's Housing Program, to wit:

However, the purchases of goods/articles by **EXCELSIUS ENGINEERING SERVICES** shall be subject to VAT, even if the said purchases are to be used for the socialized housing project, since VAT is an indirect tax which can be passed on by the seller of the goods/services.
