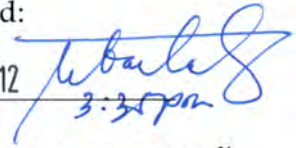

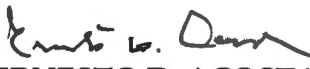
On May 2, 2012, petitioner filed a "Submission," submitting to the Court certified true copies of the following documents:

2. Tax Credit Certificate No. TCC200600003694 issued by the BIR-LTS on June 27, 2011 for the amount of PHP 21,492,476.21.

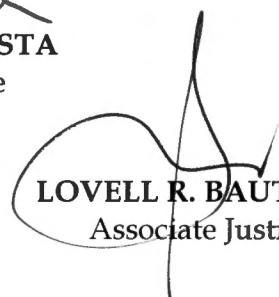

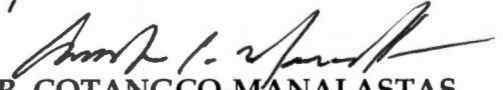
