RESOLUTION

On February 16, 2011, a *Motion for Extension of Time to File Petition for Review* was filed by petitioner Advanced Contact Solutions, Inc., praying that it be given an additional period of fifteen (15) days, or until March 3, 2011, within which to file with this Court its Petition for Review to appeal the dismissal of CTA Case No. 8100, entitled *Advanced Contact Solutions, Inc. vs. Commissioner of Internal Revenue*, rendered by the Third Division of the Court of Tax Appeals (CTA).

In a *Resolution* dated February 17, 2011, the Court *En Banc* resolved to GRANT petitioner's *Motion for Extension of Time to File Petition for Review*.

Records show that instead of filing a Petition for Review within the extended period, petitioner filed on March 8, 2011 a *Manifestation* stating that it will no longer file a Petition for Review with this Court to appeal the dismissal of the

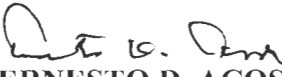

aforementioned CTA Case. Said *Manifestation* of petitioner is hereby **NOTED** by the Court *En Banc*.

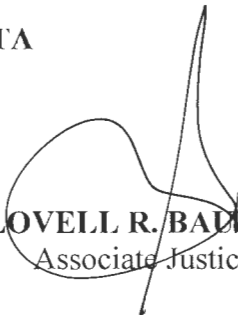

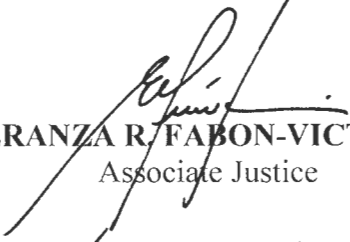
