R E S O L U T I O N

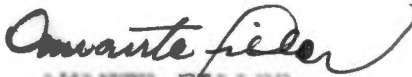

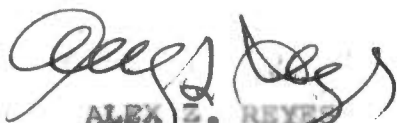
The Court resolves, as prayed for, to grant said motion.

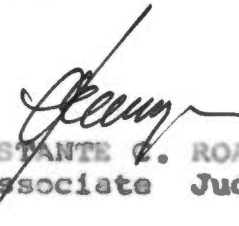
Let the petition for review be considered withdrawn and this case deemed closed and terminated.
