- 9) BIR Payment Form (0605) printed from eFPS for FWT of VAT;
- 10) Transaction Acknowledgment for WG; and
- 11) Petitioner's Letter Request for Termination/Closure of Case, dated January 2, 2012.

Both "Compliances dated February 22, 2012 and May 18, 2012" are hereby **NOTED**.

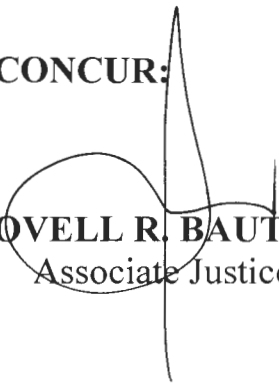
