TO : All Broker Dealer, Investment Company Advisers, Investment Houses and Transfer Agents

SUBJECT : Schedule of Fees, Fines and Penalties

Pursuant to the Securities Regulation Code [SRC] (RA No. 8799) and its Implementing Rules and Regulations, the Basic Rules to Implement the Provisions of the Investment Houses Law (P.D. 129), the Corporation Code (BP Bldg., 68) and the Investment Company Act (RA No. 2629), the following schedule of fees, fines and penalties are hereby adopted:

Failure to submit Affidavit of Non-Holding of Meeting of Postponement of Annual Stockholder's Meeting	Within 30 days from the date of postponement of the Annual Meeting	Basic fine - P10,000 Plus P100/day of delay
Failure to submit Notice of Change of Address	Within 10 days after the end of each month	Basic fine - P10,000 Plus P100/day of delay
