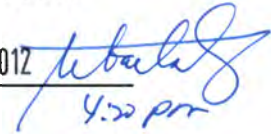

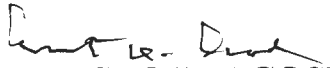
Considering that both respondents interpose no objection to the motion, the Court hereby grants said motion.
