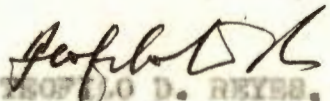
Petitioners presented a motion withdrawing their

been settled to the satisfaction of the parties and

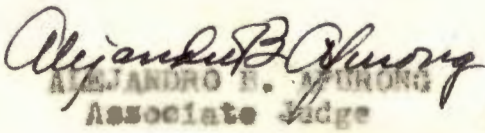
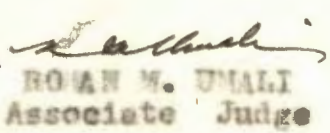
